- (x) To transact any business as raised by the membership.
- 1. Proposal to elect/appoint the head umpire at the mtg. Perhaps the way this should work is that the head of the umpiring committee selects the person subject to approval by the Exec Comm rather than have this be a directly elected position by a full club vote. Having a full club vote for this position could be time consuming if we need to replace the head umpire mid season.

The following resolution was passed by unanimous consent: The head umpire shall be nominated by the Umpiring Committee. The Executive Committee shall vote upon the nomination.

2. Need to discuss rule 6.(f) of the BAFHA By-Laws: "Each member club must be represented on the Executive Committee. No member club shall have more than two (2) people on the Executive Committee."

The rule has been amended to read: "No member club shall have more than two (2) people on the Executive Committee." Passed by unanimous consent.

- 3. James Robinson was nominated to the Head Umpire position by the Umpiring Committe. The selection was approved by the Executive Committee.
- 4. To encourage better attendance at the AGM, a resolution was passed to grant a \$50 discount

- in the 2006 season league dues for any team attending this AGM. Passed by unanimous consent.
- 5. The following resolution passed by unanimous consent: "The discount for attendance at the AGM will be considered again for next year's dues. The amount is to be discussed at next year's AGM."
